- St. Louis County updates
 - Paramedic Co-responder RN instead of MHP HDC has hired an RN for this position,
 will be starting soon. Will work with the Fire Department
 - CADT hiring position that is embedded with DPD-to be announced
 - COSAAP grant (RAD/County collaboration) Jenny Swanson/Beth Elstad
 - Jenny Swanson update-SLC jail, RAD DFMC and HDC. Make sure that people within jail get MAT, Peer Recovery, and Hot Hand Off. All positions have been hired and the work is starting.
 - 2nd COSSAP with Task Force-tracking non-fatal overdose. LSDVCTF hire an additional Peer Recovery Specialist and LADC to do assessments. Pre Arrest Diversion Program-complete intake with Jess and agree to R25. Hiring another Peer Specialist in the fall.

- Recovery Alliance Duluth (RAD) Updates
 - Community Events (Success)
 - Arrowhead Emergency EMS partnership along with Essential and St, Luke's.
 Starting Inductions in the hospitals
 - Offering paid internships (for dislocated workers due to OUD) goal is to get people trained and get hands on experience
 - Safe Babies court-working with 15 individuals providing peer recovery support
 - Working with CFS (families and parents)
 - Hygiene and food deliveries continue-may change as weather changes
 - Community events have had 500 people in attendance- North and South
